ADVERTISEMENT

Applications are invited from eligible Indian citizen as defined in Article 5 to 8 of the Constitution of India and permanent residents of Assam for filling up **141 vacancies of Post Graduate Teachers in the different Provincialised Secondary Schools** under the Director of Education, BTC, Kokrajhar in the scale of pay of **Rs.22,000/- to 97,000/-** including Grade Pay of **Rs. 11,800 /-** PM (under Pay Band- 3) plus other allowances as admissible under Rules.

The District-wise, subject-wise, medium-wise and category-wise posts details as well as date and time of receipt of online applications for TET cum Recruitment Test and other details will be notified in the official website at <https://education.bodoland.gov.in> in due course of time. Vacancies may vary due to administrative reasons. The Director of Education, BTC, Kokrajhar reserves the right to make changes in sequence of the recruitment process after publication of this advertisement.

The Director of Education, BTC, Kokrajhar reserves the right to cancel or postpone the recruitment at any stage without assigning any reason.

The aspiring candidates must be ready to serve in their respective places of posting in terms of choice of their Districts.

➤ **CONDITIONS OF RECRUITMENT:-**

Academic and professional Qualifications:

- i. The applicant must be a Post Graduate in concerned subject with at least 50% marks (or its equivalent) from recognized University and should possess Bachelor of Education (B.Ed.) qualification from an institution recognized by National Council for Teacher Education. Degrees obtained in off-campus and distance education mode shall not be considered as valid.
- ii. The candidate shall have to read the same subject as one of the subjects in degree level.
- iii. In addition to the academic and professional qualification, the applicant must satisfy the following criteria;
 - (a) In case of Assamese Medium School, the applicant must have passed HSLC or equivalent examination with Assamese language as one of the subjects or have diploma in Assamese Language issued by the Assam Sahitya Sabha or read up to HSLC level in Assamese Medium School.

- (b) In case of Bengali Medium School, the applicant must have passed HSLC or equivalent examination with Bengali language as one of the subjects or have Diploma in Bengali issued by the Barak Upatyaka Bangya Sahitya O Sanskriti Sammelan or read up to HSLC level in Bengali Medium School.
- (c) In case of Hindi Medium School, the applicant must have passed HSLC or equivalent examination with Hindi language as one of the subjects or read upto HSLC level in Hindi Medium School.
- (d) In case of Bodo Medium School, the applicant must have passed HSLC or equivalent examination with Bodo language as one of the subjects or read upto HSLC level in Bodo Medium School.
- (e) In case of English Medium School, the applicant must have passed HSLC or equivalent examination with alternative English as one of the subject or read from Class XI onwards in English Medium School.

Provided that for recruitment of teachers for teaching MIL subjects the candidate who passed HSLC Examination with particular MIL Subject shall be considered.

1. Physical fitness:

The applicant for the post of Graduate teacher shall be:-

- i. of sound health both mentally and physically and free from any organic defect or bodily infirmity which is likely to interfere in the efficient performance of his duties; and
- ii. required to undergo medical examination before appointment to the service.

2. Criteria for selection of Post Graduate Teacher:

- (a) Teachers Eligibility Test cum Recruitment Test :

140 marks in the following paper:-

The paper shall be of 140 marks (Pedagogy – 50 marks; About Assam and its People – 50 marks; General English – 30 marks; General Studies and Current Affairs – 10 marks).

- (b) NCC / Sports / Fine Arts and Cultural Activities :

- (i) 5 marks for NCC Certificates (5 marks for “C” Certificate and 3 marks for “B” Certificate)

Or

5 marks for participation in recognized sports at National Level representing Assam

Or

5 marks for achievements in Fine Arts and Cultural Activities representing the State officially at National Level.

- (ii) Candidates who have passed the earlier Higher Secondary TET and not been appointed till date shall get weightage @ 5% of the marks secured in the TET or maximum 5 marks for selection as a Post Graduate Teacher.
- (c) During the advertisement the candidates shall apply in the particular subject in case of Post Graduate Teacher.
- (d) There shall be one common question paper for all vacancies irrespective of Subjects for Post Graduate Teacher recruitment.
- (e) The number of qualified candidates in the TET cum Recruitment Test shall be in the ratio of 1:1 of the vacancies advertised.
- (f) In case, any post remains vacant after publication of the first Merit List as per the ratio of 1 : 1, then maximum 2 (two) more numbers of Merit List will be published.
- (g) There shall be separate Merit List Subject-wise in case of Post Graduate Teacher.
- (h) The Merit List shall be prepared in the manner as proposed below:-
- (i) The marks secured in the TET cum Recruitment Test by the candidates of a particular subject shall be filtered out from the main list into a separate merit list of the particular subject. Similar process shall be adopted for all other subjects.

➤ **Other Criteria**

1. Candidates must have to give the choice of district as per the district drop down menu provided during online application.
2. In case two or more candidates obtained equal marks in aggregate, then the seniority of age shall be preferred.
3. As per the Assam Secondary Education (Provincialised Schools) (Amendment) Service Rules, 2021, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
4. A candidate must not be less than 21 years of age and not more than 38 years for open category, 40 years for Ex-Servicemen, 41 years for OBC/ MOBC and 43 years for SC/ ST(P)/ST(H) and 48 years for Persons with Disability (PwD) as on **1st January, 2023**.
5. No person having more than two living children on or after 01/01/2021 from a single or multiple partners shall be eligible for appointment as per the Govt. policy on Small Family Norms, the Guidelines contained in the Notification No. ABP.69/2019/17 dated 06/11/2019 and No. ABP.69/2019/18 dated 16/11/2019.

6. No offline application will be accepted in this regard.
7. The Online Applications and documents submitted by the candidates will be verified along with their original testimonials before appointment. The detailed schedule and venue for Screening/ Verification of documents will be notified in the official website. No TA/DA is admissible for verification process. Verification will be conducted simultaneously for all the Districts and the candidates will be informed either individually or collectively by the Director of Secondary Education, Assam in the official website.
8. The Online Applications and documents submitted by the candidate will be verified using modern technology with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by back office verification with the competent board/ council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper notice.
9. The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credential submitted by the candidate. Any discrepancy will lead to cancellation of the candidature.
10. The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy regarding any information / documents uploaded by the candidate is established by appropriate authority at any point of time. The candidate will be debarred from any future recruitment under Government of Assam and subsequent legal action will also be initiated against such candidate.
11. A candidate will mention and select the name of the districts for which the application is submitted.
12. When the candidates appear for the verification of documents, they must produce original certificates, testimonials and documents that were uploaded during the application stage.
13. Physical fitness as per Rule 11 of the Assam Secondary Education (Provincialised Schools) Service Rules, 2018 :-
A candidate for direct recruitment shall be :-
 - (a) of sound health both mentally and physically and free organic defect or bodily infirmity which is like to interfere with the efficient performance of his duties and
 - (b) required to undergo medical examination before appointment to the service.
14. The candidates having NOT CLEAR (NC) status against any qualification will not be eligible to apply.
15. There shall be reservation for PWD as per existing Government Rules.
16. Candidate belong to BTR shall be given 1st preference.
17. The eligible candidates shall apply in the official website of DE, BTC i.e. <https://education.bodoland.gov.in> from 10.00 A.M. of 16-02-2024 to 10.00 P.M. of 02-03-2024.

12. BTC residential certificate from the concerned authority.

Please Note:

- a. Candidates should be cautious while submitting the online application as once the application is submitted; they will not be allowed to re-submit any online documents or application for the second time.
- b. After successful submission of the online form, candidates shall take a print out of the form and submit the same along-with self-attested copies of mark-sheets and certificates in support of educational qualification, caste, disability, B.Ed. and co-curricular activities at the time of document verification before the District Selection Committee. Candidates must also produce original documents that have been uploaded with the online application at the time of physical verification of documents.
- c. After submitting the online application form, the candidates will get a Unique Number against the submitted application and will keep the printout of the unique Number for all future references.
- d. Candidates may note that failing to qualify in Screening / Verification of documents will result cancellation of their candidature.
- e. The office will not be responsible for any lapse in submission of online application due to any technical problem.
- f. Application seeking condonation / relaxation of any criteria should be made to appropriate authority as per applicable norms at least 7 days prior to filling up of online applications.
- g. In case of PWD candidates, screening of selected candidates will be done before appointment by the competent authority.

to be submitted online:

- i. Mark sheet of HSLC, HSSLC, BA/ B. Sc./B.Com & MA / M.Sc. / M.Com.

- iii. Pass Certificate / Admit Card of HSLC in support of age.
- iv. Certificate and Mark sheet of B.Ed.
- v. Candidates with disabilities will have to enclose certificates of disabilities issued by Govt. authority.
- vi. Certificate of Ex-servicemen issued by the Director, Sainik Welfare Board.
- vii. BTC residential certificate from the concerned authority.
